# 1.6 National President's Report

Vice-President, **Rhys Burton** read the President's Report on behalf of the President, **Mark Rawson**. In doing so, he conveyed the strong sense of passion and commitment the President holds for the organisation and the industry.

# 1.7 ECANZ Board Chair Report

As circulated to members in the Annual Report, Omri Ash, read his Board Chair's Report.

Rhys acknowledged Omri's appointment as Board Chair in 2024 and thanked him for his leadership and contribution over the past year.

# 1.8 Finance, Audit and Risk Committee Report

The Finance, Audit and Risk (FAR) Committee report, as included in the Annual Report, was taken as read.

**Ross Beal**, FAR Chairman, spoke to the report, providing a brief overview of the Committee's role and responsibilities. He acknowledged the ongoing work with Master Electricians Finance team and extended thanks to fellow FAR Committee members Mike Barr and Martin Sawyers, as well as the ECANZ Board Chair, Board, and CEO for their continued efforts in maintaining a strong financial and governance position.

Ross also extended best wishes to Mark Rawson for his health and recovery.

# 1.9 Chief Executive Officer Report

The Chief Executive, **Alexandra Vranyac-Wheeler**, noted that her written report was included in the Annual Report and taken as read. She provided a broader overview and recap of the organisation's current state, recent progress, and future direction.

Alex reflected on 2024 as a significant and diverse year for Master Electricians – one of transformation, growth, and renewed strategic focus. She emphasised the organisation's core purpose to **Advocate**, **Educate and Support**, highlighting key milestones and thanking the wider team, including NPAF, Branch Delegates, the Board Chair, Sponsors and members, for their continued support and commitment.

Alex also acknowledged the efforts of the national office team and the Board in delivering through a year of considerable change.

# **Key Highlights from the CEO's presentation:**

• **Vision and Purpose:** Reinforced the organisation's commitment to maintaining relevance and implementing the new Constitution.

#### • 2024 Year in Review:

- Strong membership growth and improved engagement with non-members through professional development courses.
- Focus on celebrating success and setting a clear strategic direction, with emphasis not just on growth, but on enhancing value for existing members.
- The year marked by major changes including the sale of Martynsfield property and divestment of ICE shares.

#### • Financial Performance:

- Acknowledged abnormal expenses tied to increased legal support for advocacy activities (e.g. Serene heater issue).
- Advocacy efforts have contributed positively to member visibility and new membership growth.

### • Financial Stewardship & Sustainability:

- Growth in **sponsorship income** and strategic initiatives aimed at diversifying revenue streams.
- Highlighted the role of **Trade Master** reinforcing that every dollar spent through Trade Master goes back into the industry.

### Advocacy & Industry Engagement:

- Recognition of the appointment of Simon Rogers to the EWRB, a positive step for industry influence.
- Encouragement for members to engage actively with NPAF and local branches to contribute to a unified industry voice.

#### • Member Benefits & Looking Ahead:

- o As at 31 May, key metrics were provided.
- Strong early registrations for the upcoming Conference, the first in 5–6 years, which also celebrates the Association's centenary.

### • Strategic Partnerships:

 Recent signings with EECA and CHASNZ noted as important collaborations supporting course development and member value.

Alex encouraged ongoing support for **upcoming Trade Master courses**, and welcomed members to visit the new **Trade Master Auckland branch in Penrose**. The team, including Raymond Tancrel and Andreas Kasoulides, continues to connect with members across the country.

#### 1.14 Director's Fees

#### **ECANZ Board Chair Remuneration increase**

The CEO advised that a paper regarding Directors' Fees had been circulated to members via NPAF. It was noted that a significant amount of work is undertaken by Directors across the Board, as well as in supporting NPAF, branch activities and events.

It has been some time since Director remuneration was last reviewed. The proposed increase reflects benchmarking against the Institute of Directors (IoD) guidelines, comparisons with national averages, and consideration of the increased scale and financial performance of ECANZ.

In recognition of the growing obligations and responsibilities of the role, and to bring the remuneration in line with the national average, the CEO put forward a motion to increase the Board Chair's fee by \$15,000.

# 1.15 General Business - change of boundaries

### **Branch Boundary Adjustment**

A proposal was put forward to formally adjust regional boundaries, moving the top of the South Island (including Nelson) from the Wellington Branch into the Canterbury Westland (CanWest) Branch.

There was wide support from the affected branches.

Minutes: AGM - 24 Jun 2025

- Peter (Wellington) expressed support, noting the change is the right move for better supporting members in the region.
- Tim suggested the idea of sub-branches to maintain local engagement through events and reinforced that the change was about member support, not finances.
- Auckland is exploring a similar approach for Northland through a sub-committee (not a formal sub-branch), noting a full audit would be required for any formal restructuring.
- Nigel noted that Whangārei members already attend Auckland meetings and feel well supported, indicating such arrangements can work effectively.
- Tim agreed, emphasising the need to focus on supporting members regardless of boundary structure.

Questions were raised about whether members had been consulted. Peter advised that while formal consultation did not occur, the decision was made on the basis that it is a logical and practical move. The region is better supported logistically and operationally from CanWest, especially with the Regional Manager already based there.

#### Discussion:

- Don (Southland) abstained, suggesting there should be direct consultation with the affected members.
- Rhys confirmed that Branch Rebate Levies (BRLs) for the affected members would be redirected to CanWest.
- Peter noted that Wellington had already been investing more than it received in BRLs to support these members.
- Rhys acknowledged the comment and noted that planned changes to Regional Manager deployment would ensure improved member support in the region.

**Motion:** That the boundary of the Wellington Branch be adjusted to move members located at the top of the South Island into the Canterbury Westland Branch.

Rhys read aloud Rules clauses 3.8, 11.2 and 6.2.2.4 to confirm the process. It was noted that these clauses were exercised appropriately in support of the resolution.

#### **Next Steps:**

Members will be informed via formal communications, Regional Managers, and NPAF channels. The change has also been discussed previously at both affected branches. Tim added that members from the region have been invited to the upcoming Trade Conference in Reefton, where the Regional Manager will also be present.

#### 1.16 General business

### Major Transaction Clause - 24 Allright Place

The Major Transaction Clause (MTC), introduced via NPAF in 2024, was discussed in relation to the potential sale of the property at 24 Allright Place, Mt Wellington.

While the clause was ultimately not required, due to the successful negotiation of a long-term lease agreement (6 + 6 years), this was the first time the clause was considered since its introduction. The discussion took place at an in-person NPAF meeting and was acknowledged as a valuable demonstration of democratic process and organisational transparency.

#### Life Membership Criteria

There was some confusion in the lead-up to the AGM regarding what constitutes a Life Member. Rhys is developing a formalised set of criteria to clarify the requirements and achievements that qualify an individual for Life Membership.

This draft criteria will be presented to the Board for review and then circulated to NPAF and the wider membership for feedback and consideration.

It was noted that there are many deserving individuals across the organisation, and having clear, consistent guidelines in place will help ensure appropriate recognition moving forward. The aim is to be fully prepared for nominations ahead of the 2026 AGM.

#### **General Business**

Alex acknowledged the retirement of long-standing member **Hughie Hughes** (#0024). A story is being planned to recognise his contributions as part of the Centenary celebrations.

Members were reminded that the NZ Electrical Conference will take place at the end of October. Those who have not yet registered were encouraged to do so. Alex also extended thanks to the event sponsors for their continued support and expressed hope to see many members in attendance.
